- 4. Cancellation and Rescheduling by the Foundation:** As deemed necessary, the Foundation holds the right to cancel or reschedule an event or publication at its discretion.
- 5. Invoice Terms:** Partner agreements will be invoiced net 30 days.
- 6. Payment:** Unless otherwise agreed upon in writing by the Foundation, all sponsorships or advertising payments must be received 14 days prior to the event or publication date.
- 7. Logos and Print Ad Files:** Logo files will be accepted as high resolution vector art in one of the following formats: eps, ai or pdf. Print ads will be accepted in full color as pdfs with the fonts outlined or as jpgs. Ads must be at least 300 dpi.
- 8. Banners:** For banners brought to events by the sponsor, a size of 3'x6' is recommended.
- 9. Governance:** This agreement shall be governed by, and construed in accordance with, the laws of the State of Illinois.
